## President's Report

I would like to open my report with a sincere thanks to the many members who have volunteered their time to take on both formal and informal volunteer roles within the Club over the last 12 months. A community sporting organisation is only as strong as its membership and the time and efforts its members are prepared to commit to support the club both on and off the lawn. As long as the Club remains blessed with committed members prepared to give of their time to help things keep moving along, the Club will remain healthy and well run, and assured of a sustainable future.

To help shape that future, in November 2018 the Committee prepared and adopted a Strategic Plan for the 5-year period from 2018-2023. The intent of the plan is to clearly identify what we want the Club to be and how we plan to get there in the future.

The overarching objective of the 2018-23 Strategic Plan is that the Canberra Croquet Club is one of the best croquet clubs in Australia, and is valued by its members who are playing and enjoying good croquet and gateball. To achieve this, the plan identifies 4 priority areas of activity. They are to:

1. Develop and sustain an active membership;
2. Promote and support excellence in competition and play;
3. Develop and maintain high quality lawns, facilities, equipment and clubhouse; and
4. Ensure a well-run club with sound financial management, good governance and effective communication.

The Committee's activities across the last 12 months have been focussed on taking actions that deliver on these priorities. Some of the key initiatives put in place over the last year have included:

### Develop and sustain an active membership

- Setting a membership target for the club of 120-130 members. At this level, the Committee believes the Club will have a sufficiently strong membership base to support its ongoing operations and ensure a sound financial position upon which to base future planning.
- Continuing to provide playing opportunities for our members across all mallet disciplines through access to our lawns for Club competitions, scheduled draws, coaching and practice.

### Promote and support excellence in competition and play

- The introduction of an annual Coaching Calendar to provide better structure and clearer scheduling of introductory and other coaching modules in Association Croquet (AC), Golf Croquet (GC) and Gateball across the year.
- Hosting the 2018 NSW Gateball Championships in November 2018 to provide the opportunity for our members to play in, and watch, high quality Gateball without the need to travel outside the ACT borders.
- Supporting the entry of Club teams in the 2018 World Gateball Championships and the 2019 CNSW GC Pennants competitions.

### Develop and maintain high quality lawns, facilities, equipment and clubhouse

- Entering into a new contract with our green keeper to provide for a more comprehensive lawn maintenance program that will improve the health and quality of the playing surface of our lawns in the short and longer terms. The contract entered into force in September 2018.
- Commissioning a "conditions report" of the clubhouse to better inform capital works priorities for the Club over the next few years. The report was submitted to the Committee in August 2018 and has led to actions including:

- The repair of faults in the electrical wiring in the clubhouse which posed a potential risk to the safety of members.
- The identification of trip hazards around the clubhouse that need repair. Action in this area is ongoing.
- The identification of hazardous materials in the clubhouse of which members and tradespeople undertaking remedial work on the clubhouse need to be aware to ensure their health and safety.
- The identification of remedial work on the clubhouse that needs to be undertaken to ensure the building remains in good condition. The first priority is re-painting the clubhouse exterior to address significant deterioration and flaking of the current paintwork which is compromising the structural integrity of the clubhouse. An application for an ACT Heritage grant to assist in meeting the cost of this work has been lodged. Work is expected to commence in 2019-20.
- The ongoing investigation of capital works options for providing the clubhouse with improved amenity including increased storage, improved kitchen and sanitation facilities, and disabled access.
- Implementing a new roster for cleaning the clubhouse.

Ensure a well-run club with sound financial management, good governance and effective communication

- Ongoing implementation of a balanced budget covering all recurrent costs.
- With the assistance of members, continuing to provide hirings both as a means of promoting croquet in the ACT community and as an important source of revenue for the Club.
- A review of the club website to update out-of-date policies and regulations. This is an ongoing process and work will continue into 2019-20.
- A review of the Club's records management systems that has resulted in a clean out of out-of-date and redundant hard copy documentation in the Club filing cabinet and electronic records in the Club's Dropbox resource, and the re-organisation of existing records.
- The adoption of important policies on Member Protection and Working With Vulnerable People to ensure the Club is best equipped to support its members and visitors to the Club, and is compliant with ACT Government legislation.
- Conducting a member survey to obtain demographic information and members views on assorted administrative and playing matters.
- Regular communication to members of administrative and playing news through the website and occasional President and Captain updates.

These are just a few of the many things going on at the Club to help keep our members on the lawns. And none of these things could be put into effect without the ongoing support and commitment of our members. In particular, I would like to acknowledge:

- The members of the Committee for their contributions through the year, and particularly: our Treasurer, Linda Freasier, for keeping the budget balanced and our bank accounts adequately stocked with funds to pay all the bills; our Secretary, Gerda Lambeck, for coming on board at very short notice to keep administrative matters moving along; Vice President, David Marshall,



for his support and wise counsel; Peter Dale for overseeing projects associated with improvements to the clubhouse; Kate McLoughlin for driving a number of projects for the Committee this year including the drafting of the Strategic Plan, the conduct of the Club Survey, and researching and drafting of the Member Protection and Working With Vulnerable People policies; and Peter Freer for his enthusiasm in relation to all matters coming before the Committee.

- The Playing Committee (Greg Diprose – Captain; Peter Freer – Vice Captain; Andrew Davies; Adrienne Fazekas; Ralph Richardson; and Judy Tier) for coordinating the playing side of the Club's activities including making arrangements for all Club competitions.
- Our Membership Officer, Adrienne Fazekas, for managing all arrangements associated with new members joining the Club.
- Our Hirings Coordinator, Andrew Davies, for coordinating the lawn hirings during the year, and the team of members who support Andrew by being the facilitators who chaperone lawns hirings groups (Gerda Lambeck, Ginny Graylin, Greg Diprose, Ian Nicol, Jill Jones, Judy Tier, Julie Toms, Kate McLoughlin, Margo Davies, Marilyn Smith, Nancy Scamp, Peter Dale, Peter Freer, Richard Kenchington, Rodney Teakle and Simon Fisk). During 2018-19 the Club conducted 28 hirings which raised just over \$7000 in hiring fees.
- Our Coaching Coordinator, Judy Tier, for coordinating AC, GC and Gateball coaching for the Club, and working with Dianne Gaylor, Adrienne Fazekas, Margo Davies and Ginny Grayling conducted a U3A GC introductory coaching course in March-April 2019. (And thanks, also, to Ralph Richardson and John Harris for conducting AC introductory coaching as required). With the Playing Committee, Judy has also developed the 2019 Coaching Calendar and is currently updating the coaching modules on the website;
- Peter Dale, John Harris, Julie Toms and other members who facilitated the Club's Come & Try day on 3 March 2019.
- Our Lawns Manager, Ralph Richardson, for negotiating the new contract with our green keeper and overseeing the implementation of that contract over the last 9 months. As a consequence of this work there has been a significant improvement in the quality of grass cover and the lawns are in the best condition they have been for some years.
- Those members who have helped with lawn rolling (Andrew Davies, Greg Diprose, Simon Fisk, Peter Freer, Ian Nicol, Ralph Richardson, Stephen Richards) and line marking (Adrienne Fazekas, Simon Fisk, Richard Kenchington, Stephen Richards, Peter Wood) over the last 12 months so we are all able to hit reasonably straight and between the lines.
- Those members who have taken on responsibility for keeping the clubhouse clean. Special thanks to Nancy Scamp for her commitment to this task over an extended period, to Carol Kenchington, Julie Toms and Margaret Richardson for taking on this role in early 2019, and most recently to the members who have joined the cleaning roster (Barrie Blackburn, Greg Diprose, Anne Fulker, Stephen Galliford, Jill Golley, Alison Hancock, Edward Houghton, Carol Kenchington, Gerda Lambeck, Kate McLoughlin, Richard Meacock, Marilyn Smith, Annie Tola and Julie Toms). I would encourage all members to do their bit in keeping the clubhouse clean on the basis that many hands make light work, and add their names to the cleaning roster in the months ahead.
- Our website manager, Jamie Gumbrell, for updating website entries in an efficient and effective manner.

- Our IT support team of Bob Gingold and Ben Freasier for their work in keeping on top of the IT network and updating our passwords and mailing lists as required.
- Our First Aid Officer, Jill Golley, for maintaining first aid supplies and keeping on top of which of our members have first aid qualifications.
- Our provedores, Nancy Scamp and Alan Honey for keeping the clubhouse well supplied with tea, biscuits and cleaning products; and Pam Cohen for keeping the fridge well stocked with drinks.
- Our Public Officer, Peter Tavender, for ensuring we remain compliant with reporting requirements to the ACT Government.
- Our Trophies Officer, Peter Freer, for managing the annual collection and engraving of trophies for the assorted Club competitions, and Ben Freasier for his assistance in organising the presentation of trophies.

I would also like to acknowledge the support of our sponsors. Thanks to:

- Dixon Advisory for its ongoing support of the Club through its annual community partnership donation of \$2000 that adds importantly to the Club's revenue base and also provides members with access to the company's financial services should they so wish. This is the third year of the partnership and we hope it continues to be mutually beneficial to both parties;
- Parbery for its donation of a new laptop computer to the Club this year and its assistance with printing of the 2019 Annual Report; and
- The IAG in Ainslie which has provided some in-kind support in terms of sausages for Club BBQs and prizes for raffles run in conjunction with the Club's hosting of the 2018 NSW Gateball Championships.

And finally, as always, things have been very active on the playing side of things at the Club over the last 12 months – that is the reason we are all members after all.

We now have 11 scheduled draws per week across all disciplines, plus two more when the twilight draws are in play during daylight saving months. And many of our members are using the lawns at other times through the week for Club competition games, private bookings and practice. Passing commuter traffic is likely to be very impressed by how frequently the lawns are occupied by enthusiastic croquet and Gateball players!

There were a healthy number of entries from members in the Club's annual AC and GC handicap and open competitions, the Tony Hall Cup (high-low GC doubles) and the Tavender Trophy (Gateball pairs). For those who entered, thanks for supporting them; and to those who won: congratulations.

The Club hosted the 2018 NSW Gateball Championships (16-18 November). It was great to see upwards of 70 players, officials and spectators at the Club for each day of the event. Thanks to Tournament Managers, Glen Whitehead and Judy Tier; Tournament Referees, Peter Freer and Adrienne Fazekas; and the many members who gave their time to provide catering services for the events. The lunches and afternoon teas received rave reviews from participants. The success of the event demonstrated the Club's capacity to stage high quality events, provided some of our members with the chance to play in a high-level Gateball event without having to travel, and generated a useful financial windfall for the Club.

The Club will be continuing its recent practice of hosting 1-2 CNSW or Gateball Australia events each year in 2019-20. We are hosting the CNSW 2019 GC Singles and Doubles championships on 18-22 September 2019, and I would urge members to consider entering either or both events.

The Club has always had a strong playing presence outside of Canberra with many of our members competing as individuals or as part of Canberra teams in assorted state, national and international events. So I'd also like to acknowledge Canberra members who:

- were part of the Canberra team which represented Australia in the 2018 World Gateball Championships in Brazil in September 2018;
- represented the Club in the CNSW GC Pennants competitions in 2019;
- were part of the NSW Team for the GC Interstate Cup in September 2018 (Peter Freer, Jamie Gumbrell and Kate McLoughlin);
- variously represented NSW, Victoria, SA and Tasmania in the AC Interstate Cup in March 2019 (Alan Honey, Kerri-Ann Organ, Nick Chapman, Callum Hyland and Stephen Richards); and
- the many club members who travelled outside of Canberra to play in AC, GC and Gateball events around the country.

Australia wide, croquet players are envious of the playing strength of our Club across all mallet disciplines and know they will be in a good game when they come across a Canberra member or team in an event draw. I hope many of you will continue to be good ambassadors for the Club in your croquet and Gateball pursuits next year.

While much has been achieved in the last 12 months, much still needs to be done in the years ahead to keep the Club healthy and vibrant. I ask that you support the incoming Committee and Playing Committee so the Club can continue to move forward with implementing the priorities of the 2018-23 Strategic Plan.
